


What the TARR Tool Does:

Our TARR tool looks at the Trademark application or registration number entered in ProLaw and then goes to the TARR website and downloads the PTO's current information for critical fields. A list of the fields that will be downloaded into ProLaw show at the bottom of the screen. Select or deselect any of the fields listed. By default, all fields listed are downloaded.

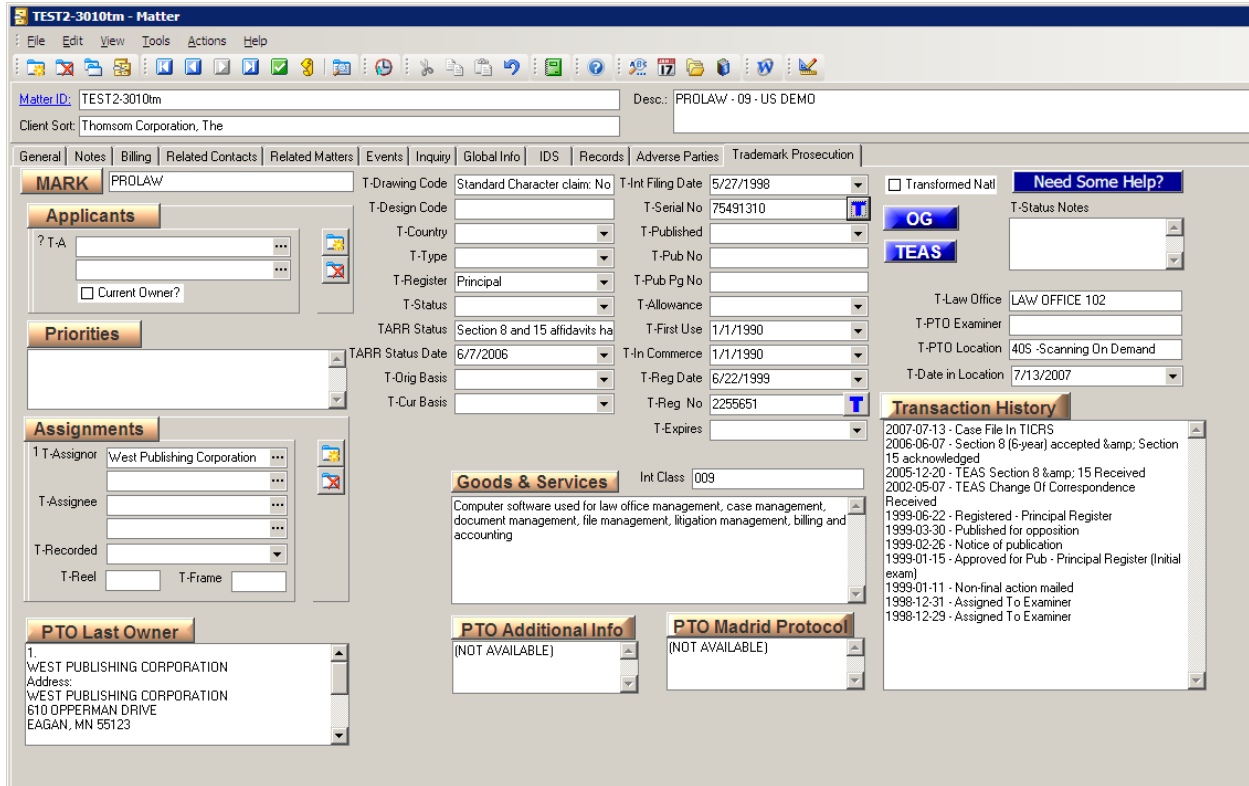
Steps to Download PAIR Data:

1. *Open Matter to Patent Prosecution Screen*

Open any U.S. Trademark Prosecution matter to the custom tab containing the prosecution data, and enter the application or registration number in the appropriate field if not there

already. (See example below of ProLaw's trademark record at the PTO. Your custom tab may look different.)

Fields used to start the PAIR tool have a Blue T to the right as shown below. Click the T next to the application or registration number field to start the program.



2. Choose Method to Save Data

To see key data before it is downloaded, click the Show Data Button. You will get a pop up that looks like the following:

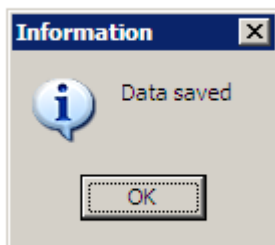
